**Tryout/Registration Fee:** All Forms must include a \$20.00 non-refundable tryout fee. Players will not be allowed to tryout without payment and registration form. (Fee includes a numbered Central FC Select Tryout T-shirt)

**Player Fees:** Players who have been selected and accept to play for a Central FC Select team must pay amount stated in the written notification (at least half) of the select player fees *within 2 weeks*. *The written notification will be a "Select Participant Financial Agreement" specific to Select team player is being placed on.* Each player will have final player fees between \$500-\$800/year, based on season/league play and number of tournaments. Player Fees include: player registration, league play, tournaments, coaching fees, and equipment fees. Players will be responsible for hotel, travel, and indoor league play.

**Club Fee:** There is a \$100 Club Fee for each PCYS family. This fee is due by May 31, 2012. PCYS will offer an activity for those families who wish to offset the cost of the club fee. Information will be available later regarding this activity.

**Uniform Fee:** Approx. \$75-\$90. All players will need to purchase a uniform if they do not possess one already. A complete uniform consists of two jerseys (home & away), shorts, and a pair of socks. Uniform fee is due when uniform order is placed.

**Volunteering:** 10 general hours *plus* 2 hours/adult/tournament are required for every Stevens Point Soccer Club family. **Required club participation** is addressed in the Parents Handbook. The Handbook can be found on the PCYS website and is updated annually.

**Fundraising:** PCYS asks all families to participate in fundraising activities it runs.

**Required forms/information:** Once a player is notified of being selected and accepts roster placement they must submit the following forms/information to be eligible: 1) Signed Financial Agreement with first payment, 2) 1"x 1" player photo, 3) Completed WYSA Release of Liability and Medical Treatment Statement forms, 4) Code of Ethics form, 5) If new to the Stevens Point Soccer Club, must present a Certified Copy of birth certificate to Club representative for completion of "Annotation of birth facts" form, 6) Junior High students also need to sign a waiver regarding school soccer play.

**Tryout Dates:** Players interested in Central FC Select are **REQUIRED** to attend all Tryout dates. Players will be invited for a callback date based on performance at initial tryout session. *Players must have all proper playing equipment, including a ball and water/liquids. Numbered t-shirt provided at registration.*

**U12-U14 – Tuesday, June 14, 2011 – Registration from 5:30-6:15, Tryout from 6:30-8:30pm At PCYS Complex**

**U15-U18 – Tuesday, June 21, 2011 - Registration from 5:30-6:15, Tryout from 6:30-8:30pm At PCYS Complex**

**Callbacks at Coaches discretion**

**Refunds/Termination:** Refund of the Player Fee will be made only under the following circumstances: 1) a season ending injury occurring before the first game of the season, and results in the player being medically ineligible for the season, or 2) the player's family moves out of the area before the first game of the season. Uniform Fees will not be refunded once a player has received his/her uniform. Any player not complying with fee payment dates can be removed from squad and not allowed to play for Central FC Select, PCYS, or the Stevens Point Soccer Club in future years until obligations are satisfied.
